4. The undersigned acknowledges that any investment in the Offering is subject to the completion and execution of certain agreements required to complete the undersigned’s subscription ( the “Offering Documents”), and the undersigned’s transfer of funds for the subscription.

5. The undersigned hereby expresses a desire to invest the Investment Amount specified below in the Offering. Notwithstanding the immediately preceding sentence, nothing herein shall commit the undersigned to invest in the Offering or the Fund to accept any subscription by the undersigned. The undersigned acknowledges that any subscription in the Offering is subject to the Fund’s sole discretion to accept such investment. The undersigned acknowledges that the Offering may be withdrawn by the Fund prior to the undersigned’s completion of the Offering Documents, without recourse against the Fund.
